




Background

- Discuss Kaiser Permanente's (KP) capability to cover early retirees and Medicare eligible retirees outside of CA who move to another KP region.
- SFHSS receives many requests from existing Kaiser Permanente members who upon retirement move out of California and want to maintain the ability to keep Kaiser Permanente as a health care offering.
- To offer Kaiser Permanente outside of California, SFHSS is evaluating contracting with three Kaiser Permanente regions; Oregon, Washington and Hawaii.

^{*}Kaiser Permanente Hawaii is headquartered on Honolulu with local markets in Kauai, Hawaii, Maui and Oahu. In January 2016, Kaiser Permanente took over Maui hospitals' operations to provide and expand healthcare services in Maui, Kula and Lanai.

^{**}Kaiser Permanente's has officially expanded access to integrated care and coverage across the state of Washington — from Seattle to Spokane and Everett to Olympia — with it's Group Health acquisition. Kaiser Permanente has committed to invest \$800 million to support the communities throughout Washington over the next decade and to invest \$1 billion over the next 10 years to expand and modernize facilities and technology and improve both care and service.

Considerations

- Allows members who had KP insurance as an active employee to keep a KP plan if inside another KP region (Hawaii, Oregon, Washington)
- Allows another choice for retirees when moving out of state if within a KP region
- KP account team would provide training for SF HSS Operations staff on eligibility and administrative process prior to OE if custom contracts implemented
- Evaluating possibility to develop one blended rate for all three regions
- Aligning benefits to match home region as close as possible
- Retiree would need to complete new enrollment form upon moving to new Region
- KP and SF HSS will evaluate administrative impact of additional contracts on SF HSS team
