OVERVIEW

The San Francisco Health Service System (SFHSS) administers health benefits for SFHSS members–employees and retirees of the City and County of San Francisco (CCSF), the San Francisco Unified School District (SFUSD), City College of San Francisco (SFCCD) and the Superior Court of San Francisco (CRT), as well as eligible dependents. This report is based on SFHSS membership demographics as of January 1, 2019.

Medical Enrollment

There were no significant changes with plan offerings for the 2019 plan year. The Blue Shield of California Trio HMO plan experienced a decrease of 1,831 lives, Blue Shield of California Access+ HMO increased enrollment by 1,537 lives and the Kaiser Permanente HMO plans increased enrollment by 1,844 lives. Since the 2018 Demographic Report, total enrollment in SFHSS medical plans increased by 2,164 covered lives. For the third consecutive year, UnitedHealthcare City Plan PPO experienced an increase in membership; this year by 117 lives.

Dental Enrollment

SFHSS administers dental plans for employees and dependents of the City and County of San Francisco and Superior Court of San Francisco, as well as retirees from all employers. Dental benefits for employees are employer-subsidized. Retiree dental plans do not receive employer subsidy and are self-funded. For Delta Dental PPO enrollees, SFHSS increased the adult orthodontic lifetime maximum from \$1,500 to \$2,500, added dental accident benefits, and introduced the *SmileWay* program for enrollees living with certain chronic conditions. In 2019, the number of lives enrolled in all SFHSS-administered dental plans increased by 1,861.

Flexible Spending Accounts

Total

A Flexible Spending Account is an IRS-approved, tax-favored account that allows employees to reduce out-of-pocket costs for certain medical and dependent care expenses. In 2019, Flexible Spending Account (FSA) participation for City and County of San Francisco and Superior Court of San Francisco employees increased for both the Healthcare and Dependent Care FSA. For 2019, SFHSS increased the maximum annual amount to \$2,650 per year. 6,125 employees enrolled in a Healthcare FSA, a Dependent Care FSA or both.

Voluntary Benefits Enrollment

Voluntary benefits offered by SFHSS to City and County of San Francisco and Superior Court of San Francisco employees provide quality coverage at group discounted rates. The premiums for the voluntary benefits are 100% paid for by the employee and are deducted from employee's pay checks. Enrollment increased in all of the voluntary benefits offered.


Abacus Short-Term Disability Insurance led the way with a 27.33% increase in subscribers, followed by a 24.81% increase in LegalShield enrollment and a 23.91% increase in Voya Accident Insurance enrollment.


In its second year being offered to all active and retired employees, enrollment in the VSP Vision Premier Plan increased by 4,585 subscribers for total subscriber enrollment of 14,742.

San Francisco Unified School District and City and County of San Francisco subscribers increased by more than fifty percent.

ENROLLED LIVES

All Employee and Retiree Members and Dependents

- Enrollment in medical coverage continues to trend upward. SFHSS now covers 122,547 lives, continuing a year-over-year trend of a 2% increase.
- The Kaiser Permanente HMO average age is 36.61 versus the 44.06 reported in the previous year's report. This is a result of breaking out the Medicare population enrolled in Kaiser Permanente Senior Advantage HMO from the population enrolled in the Kaiser Permanente HMO for more accurate comparisons. The average age of lives in Kaiser Permanente Senior Advantage HMO is slightly higher at 74.73 than those enrolled in UnitedHealthcare Medicare Advantage PPO at 74.00.
- 38% of the lives (46,929) covered under SFHSS medical plans reside in San Francisco, which is the county with the largest percentage of SFHSS lives.
- Percentage distribution of member lives by geography remains unchanged. Napa and Riverside were the only counties to experience a reduction of lives decreasing by 16 and 19 respectively.
- Proportion of employee to retiree lives enrolled in medical coverage remains unchanged for the fourth consecutive year with 69% of the total population attributed to employee lives and 31% to retiree lives.
- SFHSS has an additional 3,014 benefit eligible employees and 2,945 benefit eligible retirees who have waived coverage for 2019.


Employees:

- The ratio of employees to adult and child dependents remains constant at .97.
- 48% (19,759) of employees have no dependents enrolled in medical coverage.
- 38% of employees eligible for dental coverage do not have dependents enrolled.
- For the past six years, 27% of employees have family coverage. 4% of employees with family coverage have children only.

Retirees:


- 25% of Medicare retirees have dependents enrolled.
- Only 503 retirees have family coverage (+2 or more), which continues a year-over-year downward trend.
- Retiree lives (members and dependents) continue to trend upwards, experiencing an increase of 651 lives in the most recent year.




Medical Plan Enrollment: All Lives By County

All Covered Lives: Member vs. Dependents








- The number of SFHSS members covered by SFHSS medical plans increased by 1,158. A total of 70,134 members were enrolled as of January 2019. In contrast to last year, SFHSS retiree members outpaced the growth of SFHSS employee members by 116 members.
- The number of active and retiree members enrolled in Kaiser Permanente HMO increased by 1,017 members and comprises 55% of all member enrollment in 2019, which is a 1% increase in the proportion of member enrollment in this plan.
- Of the 28,785 medically enrolled retiree members, 23,119 are Medicare retirees and 5,666 are Non-Medicare retirees.
- UnitedHealthcare City Plan PPO enrollment for 2019 increased by 61 members to 1,878 which continues a two-year upward trend in enrollment.
- Enrollment in UnitedHealthcare Medicare Advantage PPO increased by 388 members to 12,522.
- 92% of members covered under SFHSS medical plans reside in eight Bay area counties: San Francisco, San Mateo, Alameda, Contra Costa, Marin, Solano, Sonoma and Santa Clara. 41% live in San Francisco.
- The number of employee members with domestic partners increased by 52; the number of retirees with domestic partners increased by 23. 1,485 members have a domestic partner enrolled in medical benefits with 74% (1,089) of those being opposite-sex unions.
- 58% of employee and retiree members are enrolled in member-only coverage, 26% are enrolled in member plus one dependent and 16% enrolling in member plus two or more dependents.

Average Age by Medical Plan: Employee and Retiree Members









Employees and Dependents (All Employers)

- The number of all employee lives covered by SFHSS medical plans (83,977) continued trending up. In 2019, employee lives covered by medical plans increased by 1,276. 521 of these are employee members and 755 are employee dependents.
- The proportion of employees vs. dependents enrolled in medical coverage has remained static for the last three years with 49% employee members and 51% employee dependents.
- Employee lives enrolled in Kaiser Permanente HMO increased by 1,499 thereby raising Kaiser Permanente's proportional share of employee lives by 1%. Kaiser Permanente now covers 60% of all employee lives.
- Employees and dependents enrolled in Blue Shield of California HMO decreased to 31,737 lives. This continues a downward trend of employee lives in Blue Shield. Blue Shield Trio HMO has 10,711 employee lives, a decrease from previous year and Blue Shield Access+ HMO has 21,026 employee lives, an increase over previous year.
- Enrollment in UnitedHealthcare City Plan PPO increased by 107, with a total of 1,823 employees and their dependents enrolled.
- 15% of employee members have enrolled child dependents only. SFHSS does not have the data to determine if these are single parent families, or families where there is another adult with access to other coverage.
- For the fifth consecutive year, the average age of employee members dipped slightly to 45.95. The average age of an employee dependent is 25.87, a minuscule increase. Average age for all employee and dependent members combined is 35.71.
- 97% of employee lives covered under SFHSS medical plans reside in eight Bay Area counties: San Francisco, San Mateo, Alameda, Contra Costa, Solano, Marin, Sonoma and Santa Clara. This is a 1% increase over the previous year.
- Enrollment by coverage tier for employee members remained at the same values reported for 2017: 47% of employee enrollment was in member only, member plus one dependent is 26% and member plus two or more dependents is 27%.
- When evaluating geographic disbursement of employees, the highest percentage of members, with or without dependents, live in San Francisco. 54.62% of employees without dependents live in San Francisco, a 2% reduction from last year and 38.37% of employees with dependents live in San Francisco.



Medical Coverage Level by County: Employees and Dependents


Medical Enrollment: Employees vs. Dependents

Average Age by Medical Plan: Employees and Dependents







Employee Members by County and Coverage Level






RETIREE MEMBERS AND DEPENDENTS

Retiree Members and Dependents (All Employers)

- Retiree lives continues an upward trend, increasing by another 888 lives to 38,570. Retiree members increased by 637 while retiree dependents increased by 251.
- The proportion of retirees vs. dependents enrolled in medical has remained unchanged over the past six years with lives consisting of 75% retiree members and 25% retiree dependents.
- The 2019 Demographic Report breaks out Medicare retirees from Non-Medicare retirees. Therefore, enrollment for Kaiser Permanente HMO is segmented from enrollment in Kaiser Permanente Senior Advantage (KPSA). Overall enrollment in Kaiser Permanente plans remains static. 48.44% of Non-Medicare retirees are enrolled in Kaiser Permanente HMO and 45.33% of Medicare retirees are enrolled in Kaiser Permanente Senior Advantage.
- The Blue Shield of California plans are only available for Non-Medicare retirees which accounts for the 10% enrollment percentage when taken as a percent of all retirees. When considering only Non-Medicare plans, the Blue Shield plans account for 41% of Non-Medicare retiree enrollment.
- UnitedHealthcare City Plan PPO enrollment increased to 1,013 retiree lives which are comprised of Non-Medicare retirees, Medicare-eligible but not enrolled retirees or retirees living outside of the country.
- The average age of Medicare retiree lives enrolled in medical coverage is 74.68 and the average age of Non-Medicare retiree lives is 56.14.
- The number of retiree members and dependents enrolled in coverage who reside outside of the United States of America is 50. 89 additional members live outside of the country but waive coverage.
- Retiree lives enrolled in Medicare increased to 28,864. Non-Medicare retiree lives are 9,706. Both populations are increasing slightly.
- 93% of retirees and dependents enrolled live in the state of California. 90% live in Bay Area counties: San Francisco, San Mateo, Contra Costa, Alameda, Marin, Sonoma, Solano, and Santa Clara. The number of lives increased in each of these counties.
- 12,771 (33%) retiree lives reside in San Francisco.
- Enrollment in retiree dental plans increased by 1,246 lives, which outpaced enrollment increases from the previous two years. In 2019, SFHSS introduced plan design changes for Delta Dental PPO, which increased the adult orthodontic lifetime maximum from \$1,500 to \$2,500, added dental accident benefits, and introduced the *Smilew\Way* program for enrollees with certain chronic conditions.




Medical Enrollment by Dependent Type: Retirees and Dependents



EMPLOYERS

Employers

- City and County of San Francisco covers the largest proportion of active and retiree lives at 81.26%. The San Francisco Unified School District covers 14.07%; City College of San Francisco covers 3.48% and the Superior Court of San Francisco 1.1%.
- The two smaller employers have the largest proportion of retiree lives to their total population: Superior Court of San Francisco with 57.18%, City College of San Francisco at 38.55%, San Francisco Unified School District with 36.28% and City and County of San Francisco representing 30.23%
- SFUSD has the highest proportion of employee lives enrolled in Kaiser Permanente HMO, compared to other employers. 78% of SFUSD employee lives are enrolled in Kaiser, which continues an upward trend. Kaiser Permanente has the largest enrollment percentage for each individual employer.
- SFUSD has the highest proportion of female lives at 62.71%, followed by Superior Court of San Francisco at 58.56%, Community College of San Francisco at 56.58% and City and County of San Francisco at 51.54%.
- For all employers, the average age of lives is highest for City College of San Francisco at 55.11 years and lowest for City and County of San Francisco at 44.88 years.
- For the fifth consecutive year, the number of Superior Court of San Francisco employee lives enrolled in dental has decreased, whereas City and County of San Francisco employee lives has increased.

GLOSSARY

- Lives/Covered Lives: The Plan subscribers (active and retired employees) and their covered dependents.
- Employee Members: The Plan subscriber who is an active employee.
- Retiree Members: The Plan subscriber who is a retired employee.
- Retiree Non-Medicare: Retired employee or their dependent who is not eligible for Medicare or eligible but not enrolled in Medicare.
- **Medicare Retiree:** Retired employee or their dependent(s) who is enrolled in Medicare.
- Dependents: Children, Spouse, Domestic Partner.
- Member: The Plan subscriber. When not itemized, this includes both active and retired employee.
- **Employers:** Four organizations whose health benefits are administered by the San Francisco Health Service System:
 - 1. City and County of San Francisco (CCSF)
 - 2. Superior Court of San Francisco (CRT)
 - 3. City College of San Francisco (SFCCD)
 - 4. San Francisco Unified School District (SFUSD)
