Please note that only seven (7) out of 1,759 SFFD employees (as of June 25, 2021) reside outside of California. These employees live in Colorado, Idaho, North Carolina, Tennessee and Texas. SFFD employees work an average of nine (9) shifts per month. Due to the ability to trade shifts and stack shifts, employees are able to commute from and reside outside the State of California. These employees may receive Services as a result of this RFP through tele-health and/or in-person counseling services.
