Committee Chair Scott reviewed the two documents with the Committee members. The Committee Members spoke to Executive Director Yant about some of the Board Education options-Conferences and seminars specifically. The Committee Members would like to have more

information presented to the Board members on a regular basis. Additionally, Executive Director Yant shared that the SFHSS website will be utilized as an education platform and sharing more tools on digital space. Executive Director Yant shared that there is a plan to have an education Retreat in June of every year, as well as the November Education form annually.

Ms. Leticia Pagan reviewed the Education Survey results that were collected for the 2019 education planning. Ms. Pagan stated that 4 of the 6 Commissioners responded to the survey in January 2019. Ms. Pagan noted that the highest rated presentation from the 2018 November Educational Forum, was "How do Purchasers Drive the Cost of Healthcare." Additionally, Ms. Pagan shared that most of the educational tools that are offered to the Commissioners currently are accessed rarely. Ms. Pagan stated that the education planning for the 2019 year will focus on Social Determinants of Health, Fiduciary Responsibility, and Risk Management. SFHSS will continue to survey the Commissioners throughout the year to ensure that their education plan is up to date and in line with their education needs.

Committee Member Breslin asked that a goal be added to the Education plan. This goal would state, "All Board Members need to familiarize themselves with the SF City Charter that connects to the SFHSS system." Committee Chair Scott asked that a timeline of the Rates and Benefits cycle and timeline be added to the Education Plan within the Board Commissioners Onboarding Orientation.

Committee Chair Scott asked that the Board Secretary check in with the Board members biannually regarding upcoming conferences, trainings, webinars, or meetings, to ensure that the Board members are utilizing the education budget. Committee Chair Scott stated that the Board Commissioners should be notifying the Board Secretary when they are interested in attending upcoming conferences to ensure there are funds available.
