- Catherine Dodd, HSS Director, reported on her written Director's report, as well as the following:
- In response to members' concerns regarding the absence of this year's annual HSS health fair, Margaret O'Sullivan, HSS Wellness Coordinator, is working with Kaiser to schedule member flu shots at three sites during the October Open Enrollment period.
- HSS has reviewed member utilization with Delta Dental and discovered that the plan has not been well managed. Specifically, 77% of members use Delta Dental's out-ofnetwork providers. This will be discussed in detail at next month's meeting, including recommended small plan design changes.
- In response to network questions from Commissioners Zvanski and Breslin, Dr. Dodd asked Raymond Lee, Delta Dental representative, to address the Board.
- Mr. Lee reported that Delta Dental has two networks, PPO and Premier. In the PPO Network, members pay lower out-of-pocket

costs because those dentists accept higher discounts. Members' out-of-pocket fees for Premier Network dentists (or non-PPO) are higher. In addition, the employer pays higher claims reimbursements for members' use of out-of-network services.

- The City covers all but approximately \$5 per month for members' out-of-network Delta Dental services.

Approval of proposed administrative budget for fiscal year 2012-2013 (Tracey Loveridge)

Documents provided to Board prior to meeting: Administrative Budget memo for FY 2012-2013.

- Tracey Loveridge stated that this year's budget instructions required HSS to submit administrative budgets for the next two fiscal years, 2012-13 and 2013-14.
- HSS must determine a 5% budget cut for the 2012-13 fiscal year (\$90,000) and a 10% decrease for the 2013-14 fiscal year (\$180,000) against HSS' existing base budget.
- In addition, HSS was requested to determine a 1% FTE cut for each of the next two fiscal years and a 2.5% contingency reduction.
- The two largest decreases to expenditures for fiscal years 2012-13 and 2013-14 are to consulting services and attorney's fees.
- HSS does not plan to submit the 1% FTE cut or 2.5% contingency due to the two open enrollments scheduled for this calendar year. HSS is working with the Mayor's Budget Office to complete the narrative portion of its budget submission, which is due next week.

Strategic Plan Status Update (Catherine Dodd)

 Dr. Dodd presented an update on the Health Service System's strategic plan originally submitted to the Board and approved in August 2011. She reviewed the key strengths and challenges facing the Health

Service System in 2012 as well as ongoing and new initiatives, and threats to the success of some departmental goals.

- The four strategic goals are:
 - Departmental operational excellence
 - Affordable, quality healthcare
 - Informed, transparent, effective governance
 - Educated and empowered HSS members
- The Health Service System's key strengths include innovative leadership amongst the executive staff and an extremely dedicated staff.
- One key challenge continues to be the increasing cost of healthcare. Other challenges include continued budget cuts and technology issues.

Richard Rothman, retired City employee, commented on the strategic goal of affordable, quality healthcare. He suggested that the Board conduct a brainstorming session to develop innovative approaches to affordable healthcare for HSS members, especially for retirees living outside the Bay Area.
