Commissioner Follansbee thanked Executive Director Yant and Leticia Harris for the detailed Strategic Plan close-out report and asked which 2020-2022 Strategic Plan initiatives will extend into the 2023-2025 Strategic Plan and how they will be monitored. Commissioner Zvanski asked if there are specific recruiting difficulties or if there are not enough applicants. Executive Director Yant said the 1200 classification job series is shared amongst DHR, Retirement, and the Health Service System, and the health service system has asked the Department of Human Resources

to review the 1200 series to ensure it's the right fit for our department. Executive Director Yant said Rey Guillen, Chief Operations Officer is looking to enhance training structures and qualification standards that would help the department hire people that may not have specific benefits experience. Commissioner Follansbee noted that Governor Newsom announced the California State Budget will be in a \$220 billion deficit. He asked if the Mayor's Budget takes into account the potential decrease revenues from the State. Iftikhar Hussain said the Mayor's Office said the Governor may revise the support the City receives and anticipates more information coming from the state. President Scott asked if the Board will need to resubmit the budget if there are revisions from the State. Iftikhar Hussain said he will ask the Mayor's Office how if the department will need to resubmit the budget in the State sends revisions. President Scott noted the Board will vote on the budget next month, likely without the Governor's revisions, and asked if next month is the only time the Board has the opportunity to solicit requests or changes. Iftikhar Hussain said the Board

only reviews and approves the budget in February. The Health Service Board will review the Mayor's revisions at the Health Service Board June meeting before the budget goes before the San Francisco Board of Supervisors for final approval.

Rin Coleridge said the Health Service System sets the fee and some organizations set the cost at the time it would take for the individual to copy the materials and the cost of the copies. Rin Coleridge said there haven't been any requests in their tenure as the privacy officer and the department will evaluate the appropriate fee to meet the deadline to comply. President Scott asked if he understood the process correctly: the person can make an appointment, come into the office to look at documents, and take pictures and photocopies. Rin Coleridge confirmed and added that the person can take notes as well. President Scott asked when the new regulations will come into effect. Rin Coleridge said the new regulations will possibly come out in March.

Commissioner Zvanski asked how the Health Service System verifies the individual who has made the request. Rin Coleridge said the Health Service System collects information such as date of birth, address, names, and/or social security if needed. Commissioner Zvanski said members may have dependents under their coverage and asked how individual HIPAA is protected. Rin Coleridge said every individual has HIPAA rights so a member can not look at a spouse's information or vice versa without submitting a form to grant permission. The Health Service System encourages members to complete the HIPAA forms found on the website to designate who can view member records. Rin Coleridge said if two members under the same coverage make an appointment together the formal approval is waived but this may be a situation that needs to be formalized. Commissioner Zvanski asked if the individual HIPAA rights include adult dependents adult dependent children or other adult dependents. Rin Coleridge said all adult dependents have individual HIPAA rights.

Mike Clarke said in the fall of 2022 the auditor noted a discovery of unmapped UHC claim activity for early retirees during 2022 for the Non-Medicare PPO plan, attributable to plan coding changes for UHC-administered lives in the Non-Medicare PPO plan after the transition of the majority of plan administration for the PPO to Blue Shield. If this had been discovered at the time of Aon's IBNR calculations for this plan in August 2022, it would have resulted in a higher Non-Medicare PPO plan IBNR figure by a little over \$1 million, attributable to early retirees. President Scott asked what process is in place so that there won't be a reoccurrence in the future. Mike Clarke said this coding issue did not impact the 2023 plan rating given the coding issue did not affect the 2021 plan experience used for the 2023 PPO plan rating. Mike Clarke said there is now full awareness of the coding discrepancy discovered by the auditor, so the 2022 plan experience that Aon will capture from UHC will be fully recognized in the 2024 Non-Medicare PPO plan rating (along with Blue Shield experience for this plan, also). Mike Clarke said the auditors didn't find enough of a significance in the impact on the PPO plan IBNR value to request a restatement of the reserve calculation. Iftikhar Hussain said MGO did not request a financial statement recast because the amounts were determined not to be significant. Iftikhar Hussain reassured the Board that the Health Service System will use a new structure so there are no future occurrences.

Mike Clarke said the final recommendation as of the end of the fiscal year is \$32.6 million. If the unmapped claims had been properly captured at the time Aon performed the Non-Medicare PPO plan IBNR calculation, the recommendation would have been around \$33.7 million, or an incremental difference of \$1.1 million. MGO did not ask for a financial statement recast with that incremental \$1.1 million. Commissioner Zvanski asked if there is an outstanding amount. Mike Clarke said there is no outstanding amount. President Scott asked if the auditor found this issue to be material for their report after they found the unmapped claims. Iftikhar Hussain said MGO did not report any issues and the next calculation will reflect all claims.

Julie Fernandez, Delta Dental Insurance Company. Update on the SmileWay Wellness benefits. The Smileway Wellness Benefits is on the PPO Plans for active and retirees and allows for enhanced benefits if a member has five conditions. Those conditions are diabetes, heart disease, HIV/AIDS, rheumatoid arthritis, and stroke. If a member has those conditions, they're allowed four cleanings covered at 100%, and then periodontal scaling and root planning are covered at 100% coinsurance. Delta has identified nine additional conditions that will now be available for those additional benefits. Those nine conditions are ALS/Lou Gehrig, cancer, chronic kidney disease, Huntington's, lupus, opioid misuse and addiction, Parkinson's Disease, and Sjogren's Syndrome. Delta Dental is happy to provide a meaningful enhancement to members that might be suffering from these conditions.
