#### SFHSS Health Plan RFP Past Practice

- Aug. 13, 2020 Introduction of the RFP Process for Active and Early Retiree Medical Plans for the 2022 Plan Year to the HSB
- Sept. 3, 2020 Governance Meeting Reviewed Rational and Timeline
- Sept. 10, 2020 HSB discussion of the competitive bid process for the Active and Early Retiree Medical Plan:
- Feb. 11, 2021 HSB approves contract selected through the RFP process and recommended by staff.

#### **Current SFHSS Medicare Plans:**

- UnitedHealthcare MAPD PPO
  - available to Medicare-eligible Members in all geographies since 2016
  - 17,309 covered lives<sup>1</sup>
- Kaiser Permanente Senior Advantage HMO
  - available to Medicare-eligible Members in most CA locations since before 1999, and in most WA, OR, and HI locations since 2018.
  - 14,197 covered lives<sup>1</sup>

# **Expected Outcomes - Material Budget Impact**

- 2024 Premium Contributions for City/Participating Employers<sup>1</sup>
  - Total (MA) Premium: \$117M
  - Employer Contribution: \$104M (89%)

	UHC MAPD (PPO)	KPSA (HMO)
Rate/month (2024) <sup>1</sup>	\$514.31	\$322.83
Change (2023→2024)¹	+15.0%	+6.2%

- Updated Medicare RFP Schedule:
  - December 2023: Issue MAPD (PPO) for Plan Year 2025
  - May/June 2024: Present results of MAPD (PPO) RFP to the Board
  - June September 2024: Assess MA HMO RFP for plan year 2026

# RFP Scope

- PPO population (17,309 covered lives)
- Medicare (Part A & B; Part B-only)
- Three- to five-year rate commitment
- Non-Medicare "Companion" plan administration
- Robust and stable provider network
- CMS innovation and value-added programs (meals, transportation, OTC allowance, dental, fitness programs)
- Comparable formulary and assessment of alternative formulary approaches
- Increased transparency into rates, costs, CMS revenue amounts and claims

# RFP Scope (continued)

- Best-in-class
  - medical care management
  - preauthorization/utilization management
  - concurrent review (inpatient)
  - case, demand, population, disease and co-morbidity management
- Experience in transitioning retirees and their dependents
- Support SFHSS in Member-outreach prior to Medicare eligibility
- Leading subject-matter expertise in Medicare plan administration

# Eligibility and Qualifications to Bid

- Prior experience with a diverse public sector MAPD population.
- Ability to meet the CMS waiver requirements to offer the "Passive PPO" product.
- Provide a gain-sharing agreement.
- Support our Medicare Parts A & B and Part B Only Members (MAPD plan) and non-Medicare family members (split families) through commercial coverage.
- Meet or exceed commitments to financial transparency, the SFHSS Strategic Plan, reporting, and standard City contractual terms and conditions.
