President Scott noted the report stated that United Healthcare has a contract in place with the UHC Hospital System. Executive Director Yant clarified that of the six University of California (UC) medical systems, UCSF is the only UC provider that is not contracted with UHC as an in-network provider.

Executive Director Yant said there is a new COVID vaccine as hospitalization death rates are elevated and we are in a cautious state. Commissioner Follansbee said the recommendation is for everyone to get the vaccine who completed the initial series and received the booster and said to look for communications from their health plan about the vaccine, flu, and RSV vaccines.

Commissioner Breslin asked if each of the health plans has diabetes prevention programs. Executive Director Yant said the Well-Being Division has a direct contract with the YMCA for diabetes prevention. Denise Rodriquez, Kaiser Permanente said there was a contract with Omada but would have to look into the program and follow up with Executive Director Yant. Denise Rodriquez said once a member is identified as having high blood sugar their physicians are notified and assist with prevention plans. Tiffany Gill, Blue Shield of California, said members can self-enroll in the Wellvolution program that offers diabetes education. Loir Cumming, Health Net, said there are several diabetes prevention programs in place through the wellness platform, Share Care and Omada where members can self-manage prevention programs. Monica Inocencio, United Healthcare said Medicare Advantage members have a variety of options through Optum and UHC sends prevention communications to identified members.

Health Fair and Flu Clinics Schedule

Commissioner Follansbee asked if the Southern California Kaiser system updates will help members who maintain a Northern California membership but primarily reside in Southern California to receive care in both Northern and Southern California. Commissioner Follansbee shared that he has a Northern and Southern California Kaiser Medical record number so he can use facilities but it still makes it hard to obtain lab work. Rey Guillen said the current system combines the members who live in southern and northern California into a single file and the HSS submits to Kaiser. Kaiser then has to split the files apart based on zip codes, however, this has led to significant errors and discrepancies that we hope to solve with the new system update. Rey Guillen said the membership is based on the member's residency and the system update will still place the member in the region in which they have residency. Debbie McConathy, Kaiser Permanente, said the update will be an administrative update to allow SFHSS to see the Southern California record number and Northern California record numbers. She said members have visiting member rights, where a northern California member can call the travel line to set up a Southern California medical record number to receive care but the member will still be assigned to the region of their primary residency.

Carrie Beshears, Well-being Manager with HSS, said SFHSS has been working with the YMCA for several years to provide a diabetes prevention program. During the pandemic, the program moved to virtual participation and now the program is both in-person and virtual. Carrie Beshears said an active RFP is looking at vendors to continue that program. President Scott asked if the program with the YMCA is internal to SFHSS which serves our employers and members. Carrie Beshears confirmed the program is internal and available to members, dependents, and retirees.

Commissioner Follansbee said the evolution of services available during open enrollment is fantastic. Commissioner Follansbee hoped a fact sheet on Respiratory Syncytial Virus (RSV) as well as COVID vaccinations could be available for members. Carrie Beshears said information on RSV could be added to messaging about the vaccines and flu shots. She shared that Dr. Wilson, Chief Physician, City of County of San Francisco, will be speaking at certain health fair locations about COVID boosters and available for questions.

Commissioner Follansbee asked if there is a target measure for people who enroll through eBenefits. Rey Guillen said there is not a specific target for this year. Rey Guillen said the majority of active employees select open enrollment changes online. He said SFHSS reduced the number of steps for retirees to make open enrollment elections online and hopes this increases the number of retirees using eBenefits. Rey Guillen said they will also track the number of requests for paper guides and consider transitioning retirees to digital guides for the plan year 2025.

Vice President Hao thanked Rey Guillen and Carrie Beshears for all the hard work for open enrollment and all the ways they look out for the members. President Scott acknowledged the diligence, work, and leadership and thanked all those staff named in the report and for the staff members who are not named that have brought you to this point.

<u>Dennis Kruger</u>, Retired and Active Firefighters, and Spouses expressed gratitude for the consolidated shouter open enrollment benefits guides. He asked if the individual consolidated guides included vision, dental, and Medicare plans.

Rey Guillen, Chief Operating Officer the open enrollment packet that a member gets will currently list what their current benefit elections are and who they are currently covered dependents are as well as what the premium costs will be for the available plans available to them. In addition, there is an open enrollment booklet in the retiree guide, it's a 16-page

booklet that goes through the options that retired members have for making their benefit elections for the upcoming plan year. Active employees will have that same or a similar version of that 16-page open enrollment booklet that is available to them but it will be online and available through a link or QR code that will take them directly to that place. President Scott asked if the vision, medical, and dental will all be included. Rey Guillen confirmed the open enrollment booklet for retirees does include all options that are available to them.

Commissioner Follansbee asked for clarity on section F which would grant the Board flexibility to change the open enrollment period to shorter than four weeks. Commissioner Follansbee wondered if the Health Service System would present a rationale for changing the open enrollment period before the Board approved the change. Rey Guillen said Section F updates give the Board the flexibility to dictate either an active enrollment period or shorten the length of the open enrollment. Commissioner Follansbee asked if Section F allows members to switch plans mid-year when a new plan is offered or does it means when there's a new plan option during open enrollment, the member would be required to actively decide to either stick with the old benefit plan they had and having reviewed the new one. Rey Guillen said that all plan changes would be effective at the beginning of the following year and members would only enroll during the open enrollment period. If the Board chooses, they could require a member to make an active selection, either reelecting their current plan or changing to a new plan should that be the member's desire.

President Scott noted this agenda item as Board education intended to provide context to the workings of the Board, issues that are present in the marketplace, and other forces that are shaping healthcare policy.

Commissioner Follansbee asked if survey data gathered on the Market and Health System Innovation Five Factors (Slide 5) were from public, private, government, for-profit, and non-profit groups. Anne Thompson said the resources were from significant and sizable surveys. The surveys are board-based, national, and multiple types and industries to give a board sweep of data. President Scott noted that 52% of employees would change jobs for better benefits. President Scott said in the past two decades, money was the leading indicator to cause people to change jobs, where now it's more benefits-driven than money, and bad supervision has been a driver as well.

Commissioner Follansbee said Employee experience and navigation are key and need to be proactive and said if consumers can't navigate the system, then we should question why the system exists.

Commissioner Scott asked what the three largest pharmacy benefits managers are. Anne Thompson said the three largest pharmacy benefit managers (PBMs) are Caremark (CVS), Express Scripts (Cigna), and OptumRx (United Health Group).

President Scott thanked Anne Thompson for being succinct with a large amount of information, giving a variety of examples of innovation, and sharing cogent information. Commissioner Follansbee pointed out that health care is a big business and it's getting bigger. He said the systems can work but it can often feel that we are just a drop of water in a large ocean. Commissioner Follansbee thanked Anne Thompson for the excellent overview.

President Scott mentioned the previous comment that Kaiser Permanente members have access to the urgent care centers as another point of direct care.

Commissioner Follansbee said there is a concern about the high utilization of emergency rooms for nonemergency care. He was curious to see a map of contracted urgent care centers or medical groups and which centers provide urgent care on holidays, weekends, and after hours. He acknowledged the struggle to meet the need so members have the right care, at the right place and at the right time.

Executive Director Yant asked Kaiser to comment on the SEIU campaign recently released in the press. Denise Rodriquez, Kaiser Permanente, said Kaiser and the Service Employees International Union (SEIU) met for the 7th negotiation session between September 6th and 8th. She said Kaiser supports the bargaining process and is committed to finding a resolution before the contract expires on September 30th. Members can find the latest updates at www.kp.org/labor. President Scott asked what employee populations the negotiations are affecting. Denise Rodriquez said the Coalition of Kaiser Permanente Unions represents a variety of roles and would send the list to Executive Director Yant. Executive Director Yant said we are in a time when labor unions feel the need to be loud in their requests and expects we will hear quite a bit about this negotiation. Executive Director Yant said the City of San Francisco enters negotiations with the bulk of their labor unions in January 2024.
