Yuriy Gologorskiy, SFHSS Principal Administrative Analyst, presented the following information:

President Hao asked for more information behind the decrease of \$201,000 in the Healthcare Sustainability Fund. Yuri Gologorskiy responded that net result revenues are collected through \$4 per person per month, which was recently increased, and we have further increases in plan year 2026 and corresponding expenditures for the fiscal year. So, the net result is negative. Yuriy Golorgorskiy said SFHSS uses the fund balance, so at the end of fiscal year, we still have \$6.4 million moving forward into next year. The decrease was the net result of revenues collected at \$4 per person per month, which had recently increased, combined with further planned increases in 2026 and corresponding fiscal year expenditures. He explained that the fund balance was being used, leaving \$6.4 million to carry forward into the next year.

Holly Lopez, Health Service Board Secretary, presented the following items

The presentation described the creation of an expanded calendar of actions, reports, and milestones. The Governance Committee had requested the calendar to extend beyond the usual January—June rates and benefits schedule. Its purpose was to give Commissioners insight into upcoming decisions, enhance understanding of the rates and benefits package, and highlight key decisions before the Board throughout the year. The central goal was to support Commissioners by providing a projected schedule of these upcoming decisions.

Commissioner Wilson praised the calendar, saying it was fantastic and appreciated having everything on one page. President Hao thanked the team for including the glossary and asked whether the November audit listed as an action item was the report provided to the Board. Secretary Lopez confirmed that it was the annual audit report presented by MGO each year, which the Board must approve.

Rin Coleridge, SFHSS Chief Operating and Experience Officer, and Carrie Beshears, SFHSS Well-Being Manager, presented the following items.

Commissioner Wilson expressed disappointment that flu clinics could no longer be offered. She acknowledged, however, that vaccines had since become widely available at places like Safeway and Walgreens, making the change reasonable. She emphasized the importance of education and encouragement, supported citywide communications, and mentioned that DHR takes the approach of sending messages seven times, seven different ways. She appreciated the work that had gone into the effort.

President Mary Hao remarked that the presentation showed how busy staff had been, which supported the decision to cancel the October meeting. She thanked them for their annual work in planning, managing, and analyzing the event, noting that the analysis would be presented by the current staff or their successor.

PUBLIC COMMENT:

<u>Dennis Kruger, representing Active and Retired Firefighters and Spouses</u>, asked whether printed 1145 MARKET STREET 3RD FLOOR, SAN FRANCISCO, CA 94103

materials were available for retirees who did not use computers, noting that his organization alone had over 300 such members. He wanted clarification on whether booklets or other printed resources could be requested. Rin Coleridge confirmed that members could request materials. Rin explained that the member services manager had prepared a list of key pages, since not everyone reads the full guide, and those selected materials would be available to help reduce printing costs.

Chris Sears, Ice Miller Legal Counsel, presented the following items:

President Hao asked Chris Sears to clarify the distinction between a settlor's authority to terminate or design plans and the fiduciary's responsibility to select and monitor vendors. President Hao asked how the Board should navigate situations where a health plan change—like selecting a new Medicare Advantage PPO vendor through a Request for Proposal (RFP)—creates tension between the settlor's authority to design plans and the fiduciary's duty to consider value and cost. She noted that these roles can overlap, causing confusion about responsibilities, and sought guidance on how to approach such decisions. Chris Sears explained that selecting a vendor through an RFP is primarily a fiduciary responsibility because the Board has already decided to implement a plan and must now manage plan assets to choose a vendor. While member familiarity with the incumbent and comfort levels are factors, considerations like cost, quality, and fees are central fiduciary concerns. He noted that some settlor decisions can overlap, such as benefit design adjustments, but overall, the process is mostly fiduciary. Member satisfaction and disruption are valid considerations, but they must be balanced with cost and quality to serve the plan's best interests.

PUBLIC COMMENT:

<u>Herbert Weiner</u>, appreciated the presentation for reinforcing the Board's duties and emphasized that Blue Shield serves as a case study of how problems can arise and how the Board must address them.

12. <u>REPORTS AND UPDATES FROM CONTRACTED HEALTH PLAN REPRESENTATIVES:</u> (<u>Discussion</u>)

<u>Denise Rodriquez, Kaiser Permanente,</u> provided an update on labor negotiations at Kaiser Permanente. She explained that the Alliance of Healthcare Unions, representing 61,000 employees, may hold strike authorization votes next week. She emphasized that a vote does not mean a strike will occur, and that Kaiser remains committed to resolving issues through negotiation. If a strike happens, hospitals and medical centers will stay open, with members notified of any appointment changes.

President Hao asked whether Kaiser was continuing to negotiate with the unions. Denise Rodriguez confirmed that negotiations were ongoing in good faith, with hopes of reaching an agreement by the

September 30th deadline but anticipated increased activity over the next few weeks.

Liz Kanope, Strategic Account Executive, Blue Shield of California, provided two updates on behalf of Blue Shield of California. First, she announced that, effective January 1, 2026, Blue Shield will administer behavioral health benefits for SFHSS members, pending final DMHC regulatory approval. Members who currently receive behavioral health and Applied Behavior Analysis (ABA) care through Magellan will transition to Blue Shield, with minimal disruption anticipated. Notices will be sent to impacted members in early November, and they will have up to 12 months of continuity of care with their current providers or guidance on accessing new innetwork providers. Second, Kanopy reaffirmed that Blue Shield and UC Health have reached a multi-year agreement, ensuring that SFHSS members will continue to have in-network access to UC Health physicians and facilities without any disruption.

PUBLIC COMMENT:

<u>Fred Sanchez, President of Protect Our Benefits,</u> requested a discussion with the Executive Director about Delta Dental coverage, noting it was a top concern for senior groups and members were worried since an RFP isn't planned until 2028.

<u>Herbert Weiner</u>, requested stronger dental benefits from Delta Dental, expressing concern that coverage did not adequately address increasing dental needs as members age.
